- Incomplete submissions after the deadline will not be eligible for presentation The submission must be an original research paper that has not been
- previously published or presented Submissions are accepted only in a PDF format via the Conference online

- The submitted abstract should be structured, in approximately 300 words, and should include, but not limited to, the sections of: Research Purpose; Motivation for the Study; Research Methods; Summary of Findings; Practical Implications; Contribution; and Indication of how the study relates to the conference main theme and sub-themes
